### MEMORANDUM OF UNDERSTANDING

#### AND

Mednext Biotech Limited, Araji No-1845-46-47, Near Jain temple, Iswal, Udaipur, (Raj)- 313 011, the second party, and represented herein by its Chairman and Managing Director, Mr. Anil K. Vyas, (hereinafter referred to as "Second Party", company which expression, unless excluded by or repugnant to the subject or context shall include its successors in-office, administrators and assigns). (First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party") as

#### WHEREAS:

- A) First Party is a Higher Educational Institution named: Department of Pharmaceutical Sciences, MLSU, Udaipur.
- B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- C) The Parties intent to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education and Research.
- D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests
- E) Mednext Biotech Limited, the Second Party is engaged in Business, Manufacturing, Skill Development, Education and R&D.

F) Give related information, its branches, and dimensional information about the industry concerned with whom the MoU is swom.

### NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

### CLAUSE 1 CO-PERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant Inputs to them in developing suitable teaching/training systems, keeping in mind the needs of the industry, the Second Party.
- 1.3 The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical. enter into all relevant agreements, deeds and documents (the 'Definitive Documents'') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

#### CLAUSE 2

### SCOPE OF THE MOU

- 2.1 The bodding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.
- 2.2 Curriculum Design: Second Party will give valuable inputs to the First Party in teaching training methodology and suitably customize the curriculum so that the students fit into the industrial scenario meaningfully.
- 2.3 Industrial Training & Visits: Industry and Institution interaction will give an insight in to the latest developments/requirements of the industries, the Second Party to permit the Faculty and Students of the First Party to visit its group companies and also involve in Industrial Training

Programs for the First Party. The industrial training and exposure provided to students and faculty through this association will build confidence and prepare the students to have a smooth transition from academic to working career. The Second Party will provide its Labs/Workshops / Industrial Sites for the hands-on training of the learners enrolled with the First Party.

2.4 Research and Development: Both Parties have agreed to carry out the joint research activities.

- 2.5 Skill Development Programs: Second Party to train the students of First Party on the emerging technologies in order to bridge the skill gap and make them industry ready.
- 2.6 Guest Lectures: Second Party to extend the necessary support to deliver guest lecturers to the students of the First Party on the technology trends and in house requirements.
- 2.7 Faculty Development Programs: Second Party to train the Faculties of First Party for imparting training as per the industrial requirement considering the National Occupational Standards in concerned sector, if available
- 2.8. Placement of Trained Students: Second Party will actively engage to help the delivery of the training and placement of students of the First Party into internships/jobs, and will facilitate placements of the students; The Second Party will itself absorb trained students.
- 2.9 Both Parties to obtain all internal approvals consents, permissions, and licenses of whatsoever nature required for offering the Programmes on the terms specified herein
- 2.10 There is no financial commitment on the part of the Department of Pharmaceutical Sciences, MLSU, Udaipur, the First Party to take up any programme mentioned in the MoU. If there is any financial consideration, it will be dealt separately.

### CLAUSE 3 INTELLECTUAL ROPERTY

3.1 Nothing contained in this MOU shall, by express grant, implication. Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party

### CLAUSE 4 VALIDIY

- 4.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period Mednext Biotech Limited, the Second Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of Mednext Biotech Limited, the Second Party after termination of this Agreement by way of communication, correspondence etc. shall not be construed as an extension of this MOU.
  - 4.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.

### CLAUSE 5 RELATIONSHIP BETWEEN THE PARTIES

5.1 It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.

- Joint National / International Innovation related event / competitions / sessions / workshop.
- 5. Possible support in term of placements / trainings / internships program for the students.
- 6. Organization banner and Link of organization at official website and social media network.
- 7. Recognition listing as Knowledge Partner in the conference program / proceedings and also as Knowledge Partner.
- 8. Further, whenever any of the party organizes any event, such as conference, workshop, etc., the organizing party is willing to provide fair discount to either the members or collaborators of another party.
- 9. Operant Pharmacy Federation provide Scientific Advantages to Students, Researchers and Faculties of Department of Pharmaceutical Sciences, Mohanlal Sukhadia University, Udaipur.
- 10. Both organizations also willing to share corporate contacts details.

11. Whenever, any organization avails financial benefits from third party then they are ready to share monetary benefits with other party.

#### General Terms of MOUs-

- a. Amendments- Either party may request changes to this MOU. Any changes, modifications, revisions or amendments to this MOU which are mutually agreed upon by and between the parties to this MOU shall be incorporated by written instrument, and effective when executed and signed by both parties to this MOU.
- b. Applicable Law- The construction, interpretation and enforcement of this MOU shall be governed by the laws of the State of Rajasthan. The courts of the State of Rajasthan shall have jurisdiction over any action arising out of this MOU and over the parties, and the venue shall be the [Pali, India], [Rajasthan]
- c. Entirety of Agreement. This MOU, consisting of [Main MOU Copy], represents the entire and integrated agreement between the parties and supersedes all prior negotiations, representations and agreements, whether written or oral.
- d. Duration of MOU- This MOU is at-will and may be modified by mutual consent of authorized officials from Operant Pharmacy Federation & Department of Pharmaceutical Sciences, Mohanlal Sukhadia University, Udaipur. This MOU shall become effective upon signature by the authorized officials from the Operant Pharmacy Federation & Department of Pharmaceutical Sciences, Mohanlal Sukhadia University, Udaipur and will remain in effect until modified or terminated by any one of the partners by mutual consent. In the absence of mutual agreement by the authorized officials from Operant Pharmacy Federation & Department of Pharmaceutical Sciences, Mohanlal Sukhadia University, Udaipur this MOU shall end on May 17, 2028.
- e. Coordination- In order to carry out and fulfill the aims of this agreement, each party will appoint an appropriate person(s) to represent its organization and to coordinate the implementation of activities. Operant Pharmacy Federation and Department of Pharmaceutical Sciences, Mohanlal Sukhadia University, Udaipur staff will coordinate to discuss progress and plan activities.
- f. Technical & Financial Support- Addendums to this MOU will be developed for specific technical and financial support activities. These Addendums will provide a detailed description of the role, responsibility, and financial contribution of each party. Work plans and reporting requirements will be clearly outlined in the Addendums.
- **g.** Confidentiality- Each party agrees that it shall not, at any time, after executing the activities of this MOU, disclose any information in relation to these activities or the affairs of business or method of carrying on the business of the other without consent of both parties.
- h. Termination of MOU- We are Believe in Long Term Relationship. The partnership covered by this MOU shall terminate upon completion of the agreed upon period. The agreement may also be terminated with a written three month notice from either side. In the event of non-compliance or breach by one of the parties of the obligations binding upon it, the other party may terminate the agreement with immediate effect.

- i. Extension of Agreement- The MOU may be extended provided the parties agree upon, and can provide the necessary resources.
- j. Communications- All notice, demands and other communication under this agreement in connection herewith shall be written in English language and shall be sent to the last known address, e-mail, or fax of the concerned party. Any notice shall be effective from the date on which it reaches the other party.
- **k.** Third Party Beneficiary Rights- The parties do not intend to create in any other individual or entity the status of a third party beneficiary in above commitments, and this MOU shall not be construed so as to create such status. The rights, duties and obligations contained in this MOU shall operate only between the parties to this MOU, and shall inure solely to the benefit of the parties to this MOU. The provisions of this MOU are intended only to assist the parties in determining and performing their obligations under this MOU. The parties to this MOU intend and expressly agree that only parties signatory to this MOU shall have any legal or equitable right to seek to enforce this MOU, to seek any remedy arising out of a party's performance or failure to perform any term or condition of this MOU, or to bring an action for the breach of this MOU.

All the above mentioned agreement points are subject to change only after consent from both the organizations in written. This agreement will be in effect for 5 years from the date of last signature on the understanding that subjects to revision or renewal. It may be renewed on each expiry on mutual agreement between the signatories to the memorandum. Either party may terminate this memorandum at any time by giving not less than 3 months of prior notice in writing.

- **3. Review of literature:** Enough relevant, past and recent studies should be provided and research gaps must be identified.
- **4. Methodology:** Data and study period must be recent and justifications for selecting study periods sample size, tools and techniques used should be given.
- **5. Results/Analysis:** Results and analysis should be convincing and also state whether analysis/results/findings support/reject the hypotheses.
- 6. Conclusion: Should emanate from findings
- **7. Reference:** The paper should contain full bibliographical details and journal titles should not be abbreviated. For within text citations, author's last name should be followed by comma and year of publications, all in round brackets, e.g., (Fox, 1994). At the end of the paper, there should be a reference list in alphabetical order in APA (6th ed.) format.

**Note:** Evaluation of research papers shell be based on above mentioned criteria for the purpose of "Best Paper Award".

### How to Submit Paper

The soft copy of the paper has to be uploaded with Google Registration form.

### **Review Process, Best Paper Awards and Publication**

All submitted papers are subject to a blind review by a technical committee. Each paper shall be evaluated on the basis of review criteria mentioned above.
