16.Multidisciplinary / interdisciplinary

The university encourages multidisciplinary and interdisciplinary research in its Ph.D. programme, with ongoing research projects in the institution aimed at promoting interdisciplinary studies. In the Faculty of Science, successful partnerships have emerged between the following departments-

- 1. Department of Biotechnology and Department of Zoology
- 2. Pharmaceutical Studies and Chemical Science.
- 3. Department of Biotechnology and Pharmaceutical Studies.

The Faculty of Management Studies has also collaborated with the Faculty of Commerce for various research-related activities and the Faculty of Law and Department of English frequently collaborate for research and other academic activities.

The Faculty of Humanities is following a unique practice to encourage interdisciplinary studies after successful implementation of Choice Based Credit System. Apart from the prescribed courses of the chosen subject stream, the students are offered the opportunity to opt an 'add-on course' from a selection of other subjects taught in the Faculty of Humanities. For example- students of English must opt for an add-on course from any one of the following subjects of Humanities -

- Philosophy
- Sanskrit
- Hindi

• Urdu

The Department of English also runs a very successful certificate course to teach communication skills in English, which attracts a large number of students from other streams each year. Owing to the tremendous success of this course, the Department of English has introduced more such diploma and certificate courses, which include courses on academic writing, phonetics and spoken English.

Yoga-Centre/ Promotion of Indian languages and Culture

The University has initiated severalonline courses for dissemination of Indian languages and culture, chief among them being a unique discourse based on *Shrimad Bhagvad Gita*presented by Prof. Neeraj Sharma. The total duration of thislectureseries is 300 hours and has been made available online on the university website with open access for the benefit of all. In addition to this, many online courses have also been prepared by the departments of Sanskrit, Rajasthani, Urdu and Hindi.

20.Focus on Outcome based education (OBE):Focus on Outcome based education (OBE):

All university programmes at both undergraduate and postgraduate levels are designed to facilitate outcome-based education to the students.The University continues to empower students through value-added courses designed to enhance their academic skills. Complementary coaching classes, replete with mock-exams and interviews are also organized for students, who in turn, qualify a variety of competitive exams conducted by the state and central governments, through which they either secure lucrative jobs or take up opportunities for further research in India and abroad. The University takes special pride in the large number of students from various departments who have been selected in the recent recruitments conducted by the Rajasthan Public Service Commission (RPSC). Special emphasis is laid on catering to the academic and extra-curricular needs of students belonging to rural and tribal regions. The efforts of the departments of Fashion & Textile and Women's Studies are worth mentioning in this regard. Several workshops have also been organized with special focus on the promotion of tribal arts. Interested students have received hands-on training for designing tribal jewellery and artifacts. The department of Fashion & Textile has adopted a commendable practice of encouraging sustainability by transforming waste scraps of fabric into beautiful pieces of craft or reusable items of clothing. The department also regularly promotes the skills of students by organizing exhibitions to showcase not only their talent but also gain monetary value from their creations. The department of Women's Studies especially focuses upon issues of mental and physical health of women. Throughout the year, the department organized various work shops and counselling sessions to promote the same. Both the departments are devoted to the idea of shaping financially independent and confident women. These and other efforts made by the University to promote the welfare of tribal students and women are exemplary, unique and unrivaled in Rajasthan.

21.Distance education/online education:

The practice of holding classes in hybrid mode of education during COVID-19has been continued even after the lockdowns were eased off in order to maximize academic benefits to students. Lectures are conducted in both online and offline mode as per student requirement. The University has developed an effective platform for e-content which is accessible online through the university website for the benefit of students and other interested learners. Many faculties have also created video lectures and other related e-content for the benefit of students.

1.1 - Curriculum Design and Development

1.1.1 - Curricula developed and implemented have relevance to the local, national, regional and global developmental needs which is reflected in Programme outcomes (POs), Programme Specific Outcomes(PSOs) and Course Outcomes(COs) of the Programmes offered by the University

The curricula developed and adopted by the University are designed in order to provide exposure to students regarding present and future Indian and global expectations. The University is situated in the world-class tourist-friendly city of Udaipur. Some programmes like Bachelor of Travel and Tourism Management and Bachelor of Hotel Management open avenues for graduating students to be employed in the city. Located in the scheduled area of Rajasthan, the University also offers unique courses to understand construct and culture of the region, such as -Folk literature of Vagad, Geography of Rajasthan and Sociology of Tribe.

Looking at the evolving demands of the market and industry, a number of new professional UG, PG, Diploma and Certificate programmes were introduced in the session of 2021-22, such as -Bachelor of Technology, Bachelor of Architecture, Master of Vocation (Accounting, Taxation and Auditing), Certificate programmes in Mushroom Cultivation, PG Diploma Course in Cyber Security, Diploma in Fashion Merchandising and Readymade Garments, PG Diploma in Rehabilitation Psychology etc.

The University has also collaborated with institutions of national importance and provided opportunities of different skill based courses to the students, for example, the Department of Geography is coordinating online training courses offered by ISRO.

Courses such as Ethics and Profession, Values and Ethics in Administration, Applied Ethics, and Business Ethics inculcate a professional ethos among students. Courses such as Moral Philosophy, Gandhian Philosophy, and Bhartiya Darshan indicate the dedication of the University toward instilling moral values in the youth.

Further programmes and courses offered on Yoga are designed to spread indigenous health skills among the students.

Additionally, courses on Environmental Sciences, Environmental Monitoring, Management and Restoration, Waste Management Disaster Management, etc., ensure that students are well acquainted with the environment and work together to achieve the goals of sustainable development.

The University has a UGC-sponsored Center for Women Studies, which offers under-graduate (UG) and Diploma courses related to women's and gender studies to inculcate feelings of respect for fellow citizens in the society. Programmes offered by the Faculty of Humanities also include courses on issues related to gender and women.

The courses on women studies, yoga, and human rights are also offered at the UG level as optional courses, whereas environmental studies is a mandatory course at this level in the University.

2.3 - Teaching- Learning Process

2.3.1 - Student centric methods, such as experiential learning, participative learning and problem-solving methodologies are used for enhancing learning experiences

In many professional courses innovative teaching pedology is being used for enhancing experiences of learners. Case study approach, group presentations, live projects, field visits, workshops etc. are regularly conducted for imparting education in a practical way. Experiential learning is practiced by research scholars to enhance their teaching and onward knowledge transmission skills. The scholars also take practical classes and field-based case studies to build their research aptitude. UG and PG students are encouraged to attend laboratory classes to understand concepts through experiential learning. Students are assigned certain tasks especially in organizing mega events such as international, national conferences, preparing software modules for harnessing their skills. For example, PG and Ph.D. students of Geology Department are hosts to a yearly national level programme of Geoyouth for participative interaction.

Participative learning is based on curricular and extracurricular activities which run in universities throughout the year in form of various activities. Students not only participate in routine academic assignments but also enthusiastically take part in sports, NSS, NCC, Yoga based activities to keep themselves abreast with the societal affairs. Active participation student union election is the utmost learning experience for participation in democratic values.

Mohanlal Sukhadia University has been a pioneer in implementing examination reforms in this region. In 1998 University adopted a barcode and sticker based system to minimize manual intervention in result preparation. An integrated ERP system has been established under the aegis of ITI New Delhi, a govt. of India undertaking and has been named as Integrated University Management System (IUMS). This ERP has lead to an almost paperless system integrating all affiliated and constituent colleges of the University. The entire student information is maintained through a centralized database leading to consistency and integrity of data. Separate window has been provided to various stakeholders for continuous updation of student performance and a wide range of report options are provided to provide an effective MIS. The Examination and Secrecy departments have been successful in establishing in-house facilities for barcoding, scanning, result preparation and declaration. CBCS has been implanted in most of the courses and continuous evaluation through presentations, mid-term and end term exams is central to this scheme. Currently efforts are being made to automate the process of marks submission, bill generation by examiners and even online evaluation of answer sheets in select professional courses.

INFRASTRUCTURE AND LEARNING RESOURCES

4.1 - Physical Facilities

4.1.1 - The institution has adequate facilities for teaching - learning. viz., classrooms, laboratories, computing equipment, etc.

The University is spread across 608 acres over two campuses with a total built up area of 68000 sqm. There are adequate number of class-rooms, well-equipped UG/PG/Research Labs, botanical garden, workshops, computer laboratories, e-libraries, departmental/college/university libraries, language labs, herbarium, museums clean drinking water and adequate number of washrooms etc. There are 9 hostels (3 for girls and 6 for boys).

The University Auditorium has a seating capacity of 1000, 240 sqm stage area, air cooling system, Dolby sound system and ample parking space. Administrative offices, constituent colleges and PG departments have individual seminar halls equipped with audiovisual facilities.

A part of the NKN, the University has a network supported by a
fiber optics line with a bandwidth of 1 GBPS. The Intranet is implemented through more than 500 KM of UTP cat 6 cable and 130 switches, with 100+ access points across all buildings within the campus.

The Internet centre implements, maintains and upgrades/repairs Internet services (both inter and intra net), WiFi, LAN, Broadband, etc. University Computer Centre provides Internet access to all units of the University. Departments, University college libraries, central library and computer centre have dedicated computing facilities. The University has intranet web publishing and content creation facilities.

4.1.2 - The institution has adequate facilities for cultural activities, yoga, games (indoor, outdoor) and sports. (gymnasium, yoga centre, auditorium, etc.)

The University has state-of-the-art facilities for sports and games on the campus. These include: sports and play grounds, play courts and sports equipment for indoor and outdoor games. All the sports activities are organized by Sports Board. Cultural events are handled by student councils and NSS. The activities organized range from academics to sports, dance, drama, debate, quiz, creative writing, etc. The hostels also have common rooms which are utilized by students for interaction. Ample equipment is provided for sports and games. The University also has a state-of-the-art Gymnasium, Indoor Stadium, and Kayaking and Rifle Shooting gear and equipment. Several open air theatres, which are utilized for hosting cultural and literary events, are also part of the University campus. Students who are interested in music have easy access to musical instruments, which are made available to them by the University. The University also owns and maintains an infrastructure that is self-sufficient for organizing year-round activities, such as Seminars and Conferences, Cultural fests, Annual sports and games events, inter University and intra University events, etc. Yoga is being promoted in the University through a dedicated infrastructure, and formal courses on Yoga are taught under the aegis of the University Sports Board.

4.1.3 - Availability of general campus facilities and overall ambience

The University, spread across 608 acres over two campuses with a total built up area of 68000 sqm., has excellent academic facilities and is also a green campus through rigorous plantation, water harvesting and vermicompost unit.

Residential facilities for teaching/non-teaching staff, Vice-Chancellor residence and 9 students' hostels (6 boys and 3 girls) are available. A post office and ICICI Bank branch with ATM is situated inside the main campus. AC/non-AC vehicles are available for administrative/examination work. There are several auditoriums with excellent audio-video facilities.

There is one bulk supply connection of 850 kW, several 6 kW to 658 kW connections along with several 5 kVA to 80kVA generators/invertors, 32 active bore-wells and 12 PHED connections and a wide network of CCTV cameras/guards.

The University Estate office oversees

civil/mechanical/electrical repair, garden/landscaping and general maintenance and new projects. There is an excellent Guest House with large gardens.

The Internet and Computer centres ensure extensive WiFi and computing facilities. For the differently-abled, ramps have been built at the entrance of all buildings and special toilet facilities have been placed along with adequate access to computer and other facilities at ground floors of libraries/offices. The University central library has a lift and Braille typewriter.

Network security is ensured by entry to the network strictly being through username and password generated by the Internet Centre, and through a secure software. There are firewalls, as well as excellent quality antivirus software in place to enhance cyber security and also to minimize hacking attempts and corruption of data. In addition to routine software, the University also purchases specialized software like those related to image processing, plagiarism, and other technical software, while also ensuring that no pirated software is used. From the point of view of free availability, reduction in expenditure on expensive licensing and relative security, the University strongly encourages and routinely uses Open Source Resources like Ubantu Operating Systems and Fire Fox Explorer.

The Department is headed by University Engineer and supported by a team of staff including Jr. Engineers, Plumbers, Electricians, Carpenters, etc. Cleanliness, sanitation and hygiene are given utmost importance. The task of cleaning and maintenance of the premises is outsourced and supervised by respective Department Heads. The university buildings, water tanks, covered drains, RO machines, etc., are cleaned thoroughly at regular intervals. Fumigation and pest control measures are carried out on a regular basis. The maintenance of lawns and green areas are supervised by the Heads and administration. All computing equipment, such as computers and peripherals, are maintained by the IT Department. The Lab Assistants are properly trained so that they can take care of the various labs and ensure proper upkeep of the hardware and software resources of their respective labs. Electrical equipment, such as ACs, fans, lights, etc., are maintained by the electrical wing of the University Estate Office The sports facilities are checked and maintained by the University Sports Board. 6.4 - Financial Management and Resource Mobilization

6.4.1 - Institutional strategies for mobilisation of funds and the optimal utilisation of resources

The University is state-funded and therefore, is accountable to the general public for its actions and expenditure. It follows a well-structured audit mechanism for financial management which is headed by the Comptroller (a senior state government officer of the accounts services). The Comptroller is assisted by a Deputy Comptroller, along with a full-fledged department comprising section officers, clerks and accountants. Further, the university attends the Finance Committee of the Board Meeting in which senior bureaucrats from the finance department of the state government provide detailed guidelines and procedures to be adopted for transparent system of purchasing and other expenditures. Transparency regarding E-Tenders and participation in Government E Marketplace are hallmarks of the university financial management system. Both Internal and External Financial Audits are conducted regularly. The University also has a reputed CA firm on its panel. Further, the external audit is carried out by auditors and accountants of the Comptroller and Auditor General, Jaipur. In case of any discrepancy, a para (objection) is made out by the auditors which is viewed very seriously and remedial action is taken immediately and reported back to the auditors. The University Records Section keeps documentation of the Year-wise reports of the auditors.

In case of any deficiency a para is made by auditors which is viewed very seriously and the remedial action is taken which is reported back to the auditors along with detailed reply. When they become satisfied with the reply the para is dropped. Year wise report of the auditors are available in the University Records.

The University has an efficient waste management system with special and increased emphasis on a natural and environmentfriendly organic waste disposal system. An eco-friendly initiative has been taken by the department of Zoology, to manage its own waste through Vermitechnology. Vermi-composting has been used as an effective tool for organic waste management in many communities which are largely based on agriculture. Department of Zoology has initiated the programme of Propagation of Cow dung-based Bio manure and cow urine-based pesticide through demo units, which will be soon established at each of the villages under the aegis of the University's Adopted Village Programme. Department of Zoology is the first department of the university to manage its own waste with Vermitechnology. It established its own Solid Waste Management unit through Vermicompost in 2017 and started a skill-course based on it in M.Sc. (CBCS) Programme. Every year, about 100 students, and in total about 500 students have been trained to manage solid waste of the department. The department also manages their own solid waste like department paper waste, garden waste, dead and decayed leaves, etc., through this programme. The compost generated is used in the development of the department garden and plants. In 2020, the department received a grant from RUSA 2.0 to develop a unit to train the tribal population of Rajasthan and enable them to become entrepreneurs.

The Department of English has been following a remarkable tradition of celebrating an annual debate for over 40 years in the memory of Dr. Niaz Ahmad, who served as a faculty in the department at the time of its inception.

Mohanlal Sukhadia University has been a pioneer in implementing examination reforms in this region. In 1998 University adopted a barcode and sticker based system to minimize manual intervention in result preparation. An integrated ERP system has been established under the aegis of ITI New Delhi, a govt. of India undertaking and has been named as Integrated University Management System (IUMS). This ERP has lead to an almost paperless system integrating all affiliated and constituent colleges of the University. The entire student information is maintained through a centralized database leading to consistency and integrity of data. Separate window has been provided to various stakeholders for continuous updation of student performance and a wide range of report options are provided to provide an effective MIS. The Examination and Secrecy departments have been successful in establishing in-house facilities for barcoding, scanning, result preparation and declaration. CBCS has been implanted in most of the courses and continuous evaluation through presentations, mid-term and end term exams is central to this scheme. Currently efforts are being made to automate the process of marks submission, bill generation by examiners and even online evaluation of answer sheets in select professional courses.

The University promotes participation of the faculty and students in extension activities in the neighbourhood and community, which include participation in NSS, NCC, YRC and other Regional/ National/ International programmes. The University has nine NSS units (each comprising 100 students) which engages all the faculties. All the students at the entry level are encouraged to join NCC (Air, Navy and Army) or NSS.NCC and NSS volunteers are involved in creating awareness about the environment, and generating understanding about better health management by organising camps of 1-day, 3-days 7-days or 10-days for community development.All the nine NSS units actively conduct several awareness programmes for gender sensitisation, promotion of social welfare schemes of government, ensuring good hygiene and sanitation, etc., in neighbouring villages.Retired faculty members have also formed an association which conducts seminars and provides free lectures in various underprivileged schools in and around the city. The association motivates participation of voluntary members, which includes students, to work together for the welfare of the society by offering their selfless service.

INFRASTRUCTURE AND LEARNING RESOURCES

4.1 - Physical Facilities

4.1.1 - The institution has adequate facilities for teaching - learning. viz., classrooms, laboratories, computing equipment, etc.

The University is spread across 608 acres over two campuses

with a total built up area of 68000 sqm. There are adequate number of class-rooms, well-equipped UG/PG/Research Labs, botanical garden, workshops, computer laboratories, elibraries, departmental/college/university libraries, language labs, herbarium, museums clean drinking water and adequate number of washrooms etc. There are 9 hostels (3 for girls and 6 for boys).

The University Auditorium has a seating capacity of 1000, 240 sqm stage area, air cooling system, Dolby sound system and ample parking space. Administrative offices, constituent colleges and PG departments have individual seminar halls equipped with audio-visual facilities.

A part of the NKN, the University has a network supported by a fiber optics line with a bandwidth of 1 GBPS. The Intranet is implemented through more than 500 KM of UTP cat 6 cable and 130 switches, with 100+ access points across all buildings within the campus.

The Internet centre implements, maintains and upgrades/repairs Internet services (both inter and intra net), WiFi, LAN, Broad-band, etc. University Computer Centre provides Internet access to all units of the University. Departments, University college libraries, central library and computer centre have dedicated computing facilities. The University has intranet web publishing and content creation facilities.

4.1.2 - The institution has adequate facilities for cultural activities, yoga, games (indoor, outdoor) and sports. (gymnasium, yoga centre, auditorium, etc.)

The University has state-of-the-art facilities for sports and games on the campus. These include: sports and play grounds, play courts and sports equipment for indoor and outdoor games. All the sports activities are organized by Sports Board. Cultural events are handled by student councils and NSS. The activities organized range from academics to sports, dance, drama, debate, quiz, creative writing, etc. The hostels also have common rooms which are utilized by students for interaction. Ample equipment is provided for sports and games. The University also has a state-of-the-art Gymnasium, Indoor Stadium, and Kayaking and Rifle Shooting gear and equipment. Several open air theatres, which are utilized for hosting cultural and literary events, are also part of the University campus. Students who are interested in music have easy access to musical instruments, which are made available to them by the University. The University also owns and maintains an infrastructure that is self-sufficient for organizing year-round activities, such as Seminars and Conferences, Cultural fests, Annual sports and games events, inter University and intra University events, etc. Yoga is being promoted in the University through a dedicated infrastructure, and formal courses on Yoga are taught under the aegis of the University Sports Board.

4.1.3 - Availability of general campus facilities and overall ambience

The University, spread across 608 acres over two campuses with a total built up area of 68000 sqm., has excellent academic facilities and is also a green campus through rigorous plantation, water harvesting and vermicompost unit.

Residential facilities for teaching/non-teaching staff, Vice-Chancellor residence and 9 students' hostels (6 boys and 3 girls) are available. A post office and ICICI Bank branch with ATM is situated inside the main campus. AC/non-AC vehicles are available for administrative/examination work. There are several auditoriums with excellent audio-video facilities.

There is one bulk supply connection of 850 kW, several 6 kW to 658 kW connections along with several 5 kVA to 80kVA generators/invertors, 32 active bore-wells and 12 PHED connections and a wide network of CCTV cameras/guards.

The University Estate office oversees civil/mechanical/electrical repair, garden/landscaping and general maintenance and new projects. There is an excellent Guest House with large gardens.

The Internet and Computer centres ensure extensive WiFi and

computing facilities. For the differently-abled, ramps have been built at the entrance of all buildings and special toilet facilities have been placed along with adequate access to computer and other facilities at ground floors of libraries/offices. The University central library has a lift and Braille typewriter.

It has a full-fledged Internet centre which implements, maintains and upgrades/repairs Internet services (both inter and intra net), WiFi, Broad band, etc. Access to social networks and other objectionable sites has been blocked within the campus. Network security is ensured by entry to the network strictly being through username and password generated by the Internet Centre, and through a secure software. There are firewalls, as well as excellent quality antivirus software in place to enhance cyber security and also to minimize hacking attempts and corruption of data. In addition to routine software, the University also purchases specialized software like those related to image processing, plagiarism, and other technical software, while also ensuring that no pirated software is used. From the point of view of free availability, reduction in expenditure on expensive licensing and relative security, the University strongly encourages and routinely uses Open Source Resources like Ubantu Operating Systems and Fire Fox Explorer.

4.4.2 - There are established systems and procedures for maintaining and utilizing physical, academic and support facilities - laboratory, library, sports complex, computers, classrooms etc.

The university has adequate resources for proper maintenance of the infrastructure facilities, equipment and services. A systematic procedure has been developed for the effective upkeep of the infrastructure. The salient features of the policy are as follows:

The Estate Department oversees the construction, repair and maintenance activities of the university. The Department is headed by University Engineer and supported by a team of staff including Jr. Engineers, Plumbers, Electricians, Carpenters, etc. Cleanliness, sanitation and hygiene are given utmost importance. The task of cleaning and maintenance of the premises is outsourced and supervised by respective Department Heads. The university buildings, water tanks, covered drains, RO machines, etc., are cleaned thoroughly at regular intervals. Fumigation and pest control measures are carried out on a regular basis. The maintenance of lawns and green areas are supervised by the Heads and administration. All computing equipment, such as computers and peripherals, are maintained by the IT Department. The Lab Assistants are properly trained so that they can take care of the various labs and ensure proper upkeep of the hardware and software resources of their respective labs. Electrical equipment, such as ACs, fans, lights, etc., are maintained by the electrical wing of the University Estate Office The sports facilities are checked and maintained by the University Sports Board. Annual Maintenance Contracts (AMCs)/need based visit of engineers is in place for all sophisticated equipment.

The day-to-day functioning of the university is managed by a Council of Deans which us composed of the Deans of all the constituent colleges, Dean Student welfare and Dean, PG Studies. In the constituent colleges, administration is headed by Dean and Associate Dean. Their team is assisted by a Proctor, ADSW, AO and heads of departments and different centres. The administrative set-up, policied proposed and adopted reflected in the minutes of academic council, Board of Management and decisions etc. are available on the University web site. 6.4 - Financial Management and Resource Mobilization

The University is state-funded and therefore, is accountable to the general public for its actions and expenditure. It follows a well-structured audit mechanism for financial management which is headed by the Comptroller (a senior state government officer of the accounts services). The Comptroller is assisted by a Deputy Comptroller, along with a fullfledged department comprising section officers, clerks and accountants. Further, the university attends the Finance Committee of the Board Meeting in which senior bureaucrats from the finance department of the state government provide detailed guidelines and procedures to be adopted for transparent system of purchasing and other expenditures. Transparency regarding E-Tenders and participation in Government E Marketplace are hallmarks of the university financial management system. Both Internal and External Financial Audits are conducted regularly. The University also has a reputed CA firm on its panel. Further, the external audit is carried out by auditors and accountants of the Comptroller and Auditor General, Jaipur. In case of any discrepancy, a para (objection) is made out by the auditors which is viewed very seriously and remedial action is taken immediately and reported back to the auditors. The University Records Section keeps documentation of the Year-wise reports of the auditors.

E-Tenders and participation in GeM etc. are hallmarks of the university financial management system. Both Internal and External Financial Audits are conducted regularly. The University has on its panel a reputed CA Firm. Moreover the external audit is carried out by Auditors and accountants of Comptroller and Auditor General, Jaipur. In case of any deficiency a para is made by auditors which is viewed very seriously and the remedial action is taken which is reported back to the auditors along with detailed reply. When they become satisfied with the reply the para is dropped. Year wise report of the auditors are available in the University Records.

6.5 - Internal Quality Assurance System

6.5.1 - Internal Quality Assurance Cell (IQAC) has contributed significantly for institutionalizing the quality assurance strategies and processes by constantly reviewing the teaching learning process, structures & methodologies of operations and learning outcomes at periodic intervals

The IQAC holds regular meetings to continuously monitor the quality standards across all processes followed in the University. It has closely monitored the teaching/learning methodology adopted during the critical phase of COVID-19, especially during the partial and complete nation-wide lockdowns on 2020 and 2021. The University has thus, in addition to holding regular online classes during the lockdown, also ensured regular uploading of lectures, PPTs, notes and audio lectures, among other teaching material for the aid of the students on its website. Teaching faculty continued to retain contact with students through digital tools and applications, such as Google Meet and Google Classroom. Non-teaching staff also sought to address all queries raised by students and their parents to ensure smooth functioning of all teaching activities.

The Faculty of Law organises regular awareness programmes for women in rural and tribal regions. Their aim is to spread legal awareness among women with regard to education and domestic rights. The Department of Psychology organises regular counselling sessions to help the female students adjust to the rigorous demands of academic and professional life. The university lays consistent focus on providing and maintaining excellent infrastructure and facilities for female students in the form of spacious common rooms, washrooms, etc.

The University has an efficient waste management system with special and increased emphasis on a natural and environmentfriendly organic waste disposal system. An eco-friendly initiative has been taken by the department of Zoology, to manage its own waste through Vermitechnology. Vermicomposting has been used as an effective tool for organic waste management in many communities which are largely based on agriculture. Department of Zoology has initiated the programme of Propagation of Cow dung-based Bio manure and cow urine-based pesticide through demo units, which will be soon established at each of the villages under the aegis of the University's Adopted Village Programme. Department of Zoology is the first department of the university to manage its own waste with Vermitechnology. It established its own Solid Waste Management unit through Vermicompost in 2017 and started a skill-course based on it in M.Sc. (CBCS) Programme. Every year, about 100 students, and in total about 500 students have been trained to manage solid waste of the department. The department also manages their own solid waste like department paper waste, garden waste, dead and decayed leaves, etc., through this programme. The compost generated is used in the development of the department garden and plants. In 2020, the department received a grant from RUSA 2.0 to develop a unit to train the tribal population of Rajasthan and enable them to become entrepreneurs.

Establishment of CONSTITUTIONAL PARK

The University has become the first academic institution in the country to establish a Constitutional Park in its premises. Last year, on the auspicious occasion of Indian Constitution Day, i.e., 26 November, 2021, the Honorable Governor of Rajasthan inaugurated the magnificent structure which is an aesthetic symbol of the constitutional rights and duties of Indian citizens. The constitution pillar at the center of the park is a 75 feet tall structure epitomizing the idea of freedom with responsibility. 7.3.2 - Plan of action for the next academic year

Plan of action-

The University is working zealously towards extending its academic services to the rural and tribal population of nearby regions. It is expected that the construction of the building of the proposed Girls College within the premises of Centre for Excellence at Bilota shall be completed in the next upcoming academic session. The foundation for the same has already been laid. In addition to this, the University has also proposed a project worth 200 crores forconstruction of more hostels for boys and for girls and separate hostels for the specially abled students with supporting infrastructure designed for their specific needs. The Computer Centre of the university has designed a project proposal worth 4 crores for establishment of Online Testing Centre for students of tribal regions of South Rajasthan. The center shall comprise of 500 computer systems and well trained staff for smooth conduction of various public entrance and recruitment exams that are conducted online by government bodies from time to time. Various departments of the university are also engaged in preparing Online MOOC Courses and e-content to facilitate hybrid learning among its students.
