16. Multidisciplinary / interdisciplinary

As per the mandate of the NEP 2020, the new courses in most of the Departments have been designed through GEC (Generic Elective Courses), SEC (Skill Enhancement Courses), AECC (Ability Enhancement Compulsory Courses) and similar such courses. Moreover, to facilitate networking and to establish collaborations for undertaking multi-disciplinary and interdisciplinary research, the University has to its credit, 28 functional MoUs and numerous collaborative research activities with different national and international universities and R & D institutions. The university encourages multidisciplinary and interdisciplinary research in its Ph.D. programme, with ongoing research projects in the institution aimed at promoting interdisciplinary studies. In the Faculty of Science, successful departmental partnerships have emerged between Biotechnology -Zoology, Botany-Biotechnology, Botany-Zoology, Pharmaceutical Sciences- Chemistry, Physics-Chemistry, Zoology-Microbiology, Biotechnology-Pharmaceutical Sciences etc. The Faculty of Management Studies has also collaborated with the Faculty of Commerce for various research-related activities and the Faculty of Law and Department of English frequently collaborate for research and other academic activities. Department of Accountancy and Business Statistrics has undertaken a RUSA sponsored research project on Blockchain Accounting in collaboration with Department of Computer Science. The Faculty of Humanities is following a unique practice to encourage interdisciplinary studies after successful implementation of Choice Based Credit System. Apart from the prescribed courses of

the chosen subject stream, the students are offered the opportunity to opt an 'add-on course' from a selection of other subjects taught in the Faculty of Humanities. For example-students of English must opt for an add-on course from any one of the following subjects of Humanities: Philosophy, Sanskrit, Hindi etc.

17.Academic bank of credits (ABC):

The University has in place ABC (Academic Bank of Credits) which is duly registered with NAD (National Academic Depository). The University has registered on the DigiLocker platform for National Academic Depository (NAD) depository and has signed an MoU with NSDL and accordingly has uploaded 10,99,757 degrees on Digi-locker. During 2023-24, 22,11,818 Marksheets and 51,064 Degrees have been uploaded on Digi Locker by the University.

18.Skill development:

As university has adopted NEP for all of its UG and PG Programmes, there are compulsory courses for the Skill Development of the students. There are more than fifty such courses. Skill Development and Add-on Courses are run in all programmes under NEP to inculcate professional and personality development skills like Financial Accounting Lab, Income Tax Lab, GST Lab, Practical Business Communication, Practical Business Research Methods, Business Statistics Lab, Economic Analysis with SPSS, Probiotic Technology, Business Communication, Nursery, Gardening & Green House, Application of GIS, Rachnatmak Lekhan, Scientific Writing and Numerical Analysis Techniques Using MATLAB, Solid waste management through vermitechnology, Mushroom cultivation etc.

19. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

Most of the Courses have been designed in such a way that Indian Knowledge System and its parameters are addressed. In almost all the Undergraduate programs the teaching, learning, and research are carried out in a bi-lingual mode. From time-to-time special lectures are organized for the students and the staff to propagate Indian culture, history, and other related fields of the Indian knowledge system. Department of Sanskrit, Yoga, Hindi, Urdu, Jainology and Prakrit, Rajasthani, Music, and Visual Arts conducts regular extension activities to spread awareness about Indian knowledge systems. Yoga-Centre/ Promotion of Indian languages and Culture: The University has initiated several online courses for dissemination of Indian languages and culture,

chief among them being a unique discourse based on Shrimad Bhagvad Gita presented by Prof. Neeraj Sharma. The total duration of this lecture series is 300 hours and has been made available online on the University website with open access for the benefit of all. In addition to this, many online courses have also been prepared by the departments of Sanskrit, Rajasthani, Urdu and Hindi. Pipa Peeth has been established and it is being planned to establish Centre for Indian Knowledge System.

20. Focus on Outcome based education (OBE): Focus on Outcome based education (OBE):

NEP has been implemented and the focus of all the courses taught at the University level is on the Outcome Based Education. The curricula developed and adopted by the University are needbased and outcome-oriented. They are designed with clearly-stated Programme Specific Outcomes (PSOs) and Course Outcomes (COs) thus, facilitating outcome-based education to the students. The University continues to empower students through value-added courses designed to enhance their academic skills. The University offers 38 professional, 3 Vocational, and 21 short-run valueadded programs (Certificate, Diploma, and PG Diploma) which have focus on employability of students. Programmes like Bachelor of Business Administration in Travel and Tourism Management and in Hotel Management open employment avenues for graduating students in the local and global tourism industry. Programmes like Master of Social Work, Bachelors Programmes in Technology and in Architecture, Bachelor and Master Programmes of Vocation in Accounting, Taxation and Auditing and Master of Vocation in Fashion Technology and Designing and Certificate Programmes in German and French, Diploma in Library and Information Science, Diploma in Fashion Design & Technology, Diploma in Digital Marketing and PG Diploma in Cyber Laws have also been introduced. Special emphasis is laid on catering to the academic and extracurricular needs of students belonging to rural and tribal regions. Departments of Fashion & Textile and Women's Studies host workshops with special focus on the promotion of indigenous and tribal arts to provide hands-on training to students and subsequently organizes exhibitions to showcase not only their talent but also gain monetary value from their creations. The department of Fashion & Textile has implemented an admirable strategy to promote sustainability by repurposing leftover fabric scraps to create exquisite or reusable items of clothing. The department also regularly promotes the skills of students by. Women's studies department specifically addresses issues related to women's physical and mental health and organize various work shops and counselling sessions to

promote the same. Both the departments are devoted to the idea of shaping financially independent and confident women. These and other efforts made by the University to promote the welfare of tribal students and women are exemplary, unique and unrivalled in Rajasthan.

21.Distance education/online education:

Though the University does not have any Distance Education program but it has maintained and continued the practice of holding classes in hybrid mode of education even after the lockdowns were eased off to maximize academic benefits to students. Lectures are conducted in both online and offline mode as per student requirement. The University has developed an effective platform for e-content which is accessible online through the university website for the benefit of students and other interested learners. Many faculties have also created video lectures and other related e-content for the benefit of students.

INFRASTRUCTURE AND LEARNING RESOURCES

4.1 - Physical Facilities

4.1.1 - The institution has adequate facilities for teaching - learning. viz., classrooms, laboratories, computing equipment, etc.

The University is spread across 608 acres over two campuses with a total built-up area of 68000 sqm. There are an adequate number of classrooms, well-equipped UG/PG/Research Labs, a botanical garden, workshops, computer laboratories, e-libraries, departmental/college/university libraries, language labs, herbarium, museums clean drinking water and an adequate number of washrooms etc. There are 9 hostels (3 girls6 boys).

The University Auditorium has a seating capacity of 1000, 240 sqm stage area, an air cooling system, a Dolby sound system, and ample parking space. Administrative offices, constituent colleges and PG departments have individual seminar halls equipped with audiovisual facilities.

A part of the NKN, the University has a network supported by afiber optics line with a bandwidth of 1 GBPS. The Intranet is implemented through more than 500 KM of UTP cat 6 cable and 130 switches, with 100+ access points across all buildings within the campus.

The Internet center implements, maintains, and upgrades/repairs Internet services (both inter and intra net), WiFi, LAN,

Broadband, etc. University Computer Centre provides Internet access to all units of the University. Departments, University college libraries, central library, and computer centre have dedicated computing facilities. The University has intranet web publishing and content creation facilities.

The University has state-of-the-art facilities for sports and games on the campus. These include: sports and play grounds, play courts and sports equipment for indoor and outdoor games. All the sports activities are organized by Sports Board. Cultural events are handled by student councils and NSS. The activities organized range from academics to sports, dance, drama, debate, quiz, creative writing, etc. The hostels also have common rooms which are utilized by students for interaction. Ample equipment is provided for sports and games. The University also has a state-ofthe-art Gymnasium, Indoor Stadium, and Kayaking and Rifle Shooting gear and equipment. Several open air theatres, which are utilized for hosting cultural and literary events, are also part of the University campus. Students who are interested in music have easy access to musical instruments, which are made available to them by the University. The University also owns and maintains an infrastructure that is self-sufficient for organizing year-round activities, such as Seminars and Conferences, Cultural fests, Annual sports and games events, inter University and intra University events, etc. Yoga is being promoted in the University through a dedicated infrastructure, and formal courses on Yoga are taught under the aegis of the University Sports Board.

total built-up area of 68000 sqm., has excellent academic facilities and is also a green campus through the rigorous plantation, water harvesting, and vermicompost unit. Residential facilities for teaching/non-teaching staff, Vice-Chancellor residence and 9 students' hostels (6 boys and 3 girls) are available. A post office and ICICI Bank branch with ATM is situated inside the main campus. AC/non-AC vehicles are available for administrative/examination work. There are several auditoriums with excellent audio-video facilities. There is one bulk supply connection of 850 kW, several 6 kW to 658 kW connections along with several 5 kVA to 80kVA generators/invertors, 32 active borewells and 12 PHED connections and a wide network of CCTV cameras/guards. - Research environment and infrastructure: University has ultramodern research infrastructural facilities at par with many national organizations. Many departments are equipped with hitech instruments which help to improve the level of research. State-of-the-art facilities like Central Library, Central Instrumental Laboratories (in different departments), Geological Museum, Drug Museum, Animal House, etc., are present. For visually impaired persons, library at University College of Science has established a well-equipped "Drishti" corner where literature can be accessed through audio and Braille. The University e-library has also subscribed to 8965 online journals and 171 e-books, and facilitated with OPAC. Intranet and Wi-Fi facilities installed in the University have created a tremendous impact in accelerating research output. University is accessible on maximum portals of academic importance, and as an active member of INFLIBNET and DELNET, numerous resources for information are available to cater to the needs of scholars and researchers.
- Creation and dissemination of knowledge: Regular extension activities are conducted to spread awareness about Indian knowledge system. Expert faculty from the University provides coaching and guidance to students for various Centre/State competitive exams, and organises mock interviews and training

to improve their communication skills. Seminars, conferences, workshops and training programmes are conducted regularly

NSS initiatives often include blood donation camps, environmental awareness drives, literacy programs, and health camps in nearby communities. NCC cadets participate in parades, disaster management training, and cleanliness campaigns, fostering discipline and patriotism. The Red Ribbon Club focuses on creating awareness about fatal diseases, likes AIDS and COVID, conducting free health checkups, and organizing seminars on preventive healthcare

INFRASTRUCTURE AND LEARNING RESOURCES

4.1 - Physical Facilities

4.1.1 - The institution has adequate facilities for teaching - learning. viz., classrooms, laboratories, computing equipment, etc.

The University is spread across 608 acres over two campuses with a total built-up area of 68000 sqm. There are an adequate number of classrooms, well-equipped UG/PG/Research Labs, a botanical garden, workshops, computer laboratories, elibraries, departmental/college/university libraries, language labs, herbarium, museums clean drinking water and an adequate number of washrooms etc. There are 9 hostels (3 girls6 boys).

The University Auditorium has a seating capacity of 1000, 240 sqm stage area, an air cooling system, a Dolby sound system, and ample parking space. Administrative offices, constituent colleges and PG departments have individual seminar halls equipped with audiovisual facilities.

A part of the NKN, the University has a network supported by afiber optics line with a bandwidth of 1 GBPS. The Intranet is implemented through more than 500 KM of UTP cat 6 cable and 130 switches, with 100+ access points across all buildings within the campus.

The Internet center implements, maintains, and upgrades/repairs Internet services (both inter and intra net), WiFi, LAN,

Broadband, etc. University Computer Centre provides Internet access to all units of the University. Departments, University college libraries, central library, and computer centre have dedicated computing facilities. The University has intranet web publishing and content creation facilities.

The University has state-of-the-art facilities for sports and games on the campus. These include: sports and play grounds, play courts and sports equipment for indoor and outdoor games. All the sports activities are organized by Sports Board. Cultural events are handled by student councils and NSS. The activities organized range from academics to sports, dance, drama, debate, quiz, creative writing, etc. The hostels also have common rooms which are utilized by students for interaction. Ample equipment is provided for sports and games. The University also has a state-of-the-art Gymnasium, Indoor Stadium, and Kayaking and Rifle Shooting gear and equipment. Several open air theatres, which are utilized for hosting cultural and literary events, are also part of the University campus. Students who are interested in music have easy access to musical instruments, which are made available to them by the University. The University also owns and maintains an infrastructure that is self-sufficient for organizing yearround activities, such as Seminars and Conferences, Cultural fests, Annual sports and games events, inter University and intra University events, etc. Yoga is being promoted in the University through a dedicated infrastructure, and formal courses on Yoga are taught under the aegis of the University Sports Board.

4.1.3 - Availability of general campus facilities and overall ambience

The University spread across 608 acres over two campuses with a total built-up area of 68000 sqm., has excellent academic facilities and is also a green campus through the rigorous plantation, water harvesting, and vermicompost unit. Residential facilities for teaching/non-teaching staff, Vice-Chancellor residence and 9 students' hostels (6 boys and 3 girls) are available. A post office and ICICI Bank branch with ATM is situated inside the main campus. AC/non-AC vehicles are available for administrative/examination work. There are several auditoriums with excellent audio-video facilities. There is one bulk supply connection of 850 kW, several 6 kW to 658 kW connections along with several 5 kVA to 80kVA generators/invertors, 32 active bore-wells and 12 PHED connections and a wide network of CCTV cameras/guards. The University Estate office oversees civil/mechanical/electrical repair, garden/landscaping and general maintenance and new projects. There is an excellent Guest House with large gardens. The Internet and Computer centres ensure extensive WiFi and computing facilities. For the differently-abled, ramps have been built at the entrance of all buildings and special toilet facilities have been placed along with adequate access to computer and other facilities at ground floors of libraries/offices. The University central library has a lift and Braille typewriter.

The leadership of the University, under the aegis of the Vice-Chancellor and the Board of Management, empowers the Deans and Directors, as well as the Academic Council, to take effective decisions and also supports the active participation of the faculty and staff in the process of decision making. Both, teaching and non-teaching staff, are effectively represented in the Governing Body, which is the ultimate decision-making unit of the University. Various committees, comprising teaching and non-teaching staff, are engaged in planning and implementation of curricular, co-curricular and extension activities in different spheres of institutional day-to-day functioning. The University has a number of statutory bodies to oversee its effective and smooth functioning. The Board of Management is responsible for all the major academic and administrative decisions. In the constituent colleges, administration is headed by Dean and Associate Dean. Their team is assisted by a Proctor, ADSW, AO and heads of departments and different centres. 6.4 - Financial Management and Resource Mobilization

6.4.1 - Institutional strategies for mobilisation of funds and the optimal utilisation of resources

The University is state-funded and therefore, is accountable to the general public for its actions and expenditure. It follows a well-structured audit mechanism for financial management which is headed by the Comptroller (a senior state government officer of the accounts services). The Comptroller is assisted by a Deputy Comptroller, along with a full-fledged department comprising section officers, clerks and accountants. Further, the university attends the Finance Committee of the Board Meeting in which senior bureaucrats from the finance department of the state government provide detailed guidelines and procedures to be adopted for transparent system of purchasing and other expenditures. Transparency regarding E-Tenders and participation in Government E Marketplace are hallmarks of the university financial management system. Both Internal and External Financial Audits are conducted regularly. The University also has a reputed CA firm on its panel. Further, the external audit is carried out by auditors and accountants of the Comptroller and Auditor General, Jaipur. In case of any discrepancy, a para (objection) is made out by the auditors which is viewed very seriously and remedial action is taken immediately and reported back to the auditors. The University Records Section keeps documentation of the Year-wise reports of the auditors.
