# MINUTES OF THE MEETING OF THE FACULTY OF SCIENCE HELD ON 14th May 2016

The following resolutions were taken

1. Approved the minutes of the meeting of the Faculty of Science held on 18<sup>th</sup> January,2016 with an observation that University has already issued an order establishing the new Department of Computer Science and the members appreciated the quick action by the University in the light of approval already available. As a part of resolution already passed in the last meeting, the members resolved to recommend establishment of the Department of Biotechnology and Department of Polymer Science in the Faculty of Science and State Government may be requested to provide Faculty and non-teaching positions as per UGC norms.

2. Approved the minutes of the Committee of Courses in following subjects:

(a) Botany (b) Biotechnology (c) Chemistry (d) Pharmacy (e) Physics (f) Mathematics (g) Informatics & Computational Sciences (h) Zoology

The minutes of the above Committee of Courses enclosed (Enclosure-I) with following observations and recommendations:

(a) All the committee of Courses approved the Choice Based Credit System for UG courses from session 2017-18 provided teachers are recruited have a Teacher :Student ratio of 1:20 as per the UGC/RUSA norms for imparting quality education through CBCS courses. It is unanimously resolved that quality should not be compromised in CBCS system by engaging period based guest faculty for teaching and the CBCS system is not to be followed till adequate number of faculty positions are provided as per UGC norms.

(b) The syllabus of UG courses in all the subjects are revised from session 2016-17 by adding new practicals from practical list for CBCS model syllabus of UGC. In most of the subjects Virtual Laboratories, computer based experiments etc. were also added. Further, in theory minor changes were made in the last unit by adding lectures on Nobel laureates, modern

evelopments etc. Since no questions are to be asked in theory papers from these topics, there and the the examination pattern.

eld segurate committee of courses in Computer Science may be constituted after the present en of Committee of Courses in IT&CS in the light of establishment of new department of Computer Science. Since department of Physics is more related to basic engineering subjects, the owners in the interdisciplinary area of technology and engineering including Information Technology, Nanotechnology etc. may be considered in the Committee of courses in Physics,

(d) Approved the rules and regulations for conduct of short term Diploma Courses in Tocational courses and Short term Certificate courses in Skill Enhancement Courses framed b a committee constituted by the Faculty Chairman. The committee recommended the university to consider the matter of rate of honorarium as per university norms as well as considering the effort involved in the conduct of the skill tests (Enclosure-II)

(e) From session 2016-17, the following diploma, short term diploma vocational courses, short term certificate courses for skill enhancement will be offered. The course naks, eligibility, syllabus etc. approved by the Committee of Courses are approved.

(1) Approved the curriculum for Five Years Integrated Course in MCA from session 2017-18 to be offered by the Department of Computer Science.

3. Faculty recommended that students admitted to the UG courses may be made aware the requirement of 75% attendance from the time of admission by taking an affidavit from them for the following and printing it in the information bulletin:

(a) All the students admitted as regular students of UG,PG and other courses in the faculty of science shall be required to attend 75% of the classes held in each subject in both practical and theory separately. In CBCS courses, 75% attendance will be required separately in each paper as per course rules.

(b) Attendance will be prepared by the teacher concerned and notified every month on the University website and notice board normally before 7th of every month by the Head of the Department.

(c) Candidates whose attendance is less than 75% shall not be allowed to appear in the University external examinations based on the attendance computed at the end of session/semester. However, in genuine cases decided by a committee, maximum 10% of the total classes held can be conducted as remedial classes in each paper provided the expenditure for conducting such classes will be borne by the participating students on sharing basis. No exception and relaxation in the maximum remedial classes to be held is permissible as it dilutes the attendance requirement.

(d) In case of serious medical reasons (to be decided by a committee) maximum 5% of classes lost may be allowed to be compensated by assigning written or any academic work by recording attendance as and when student returns back from medical leave.

4. Considered the list of standard journals to be approved and published on the University web site for the purpose of calculating API, publications in peer reviewed journals, etc for direct recruitment and CAS promotion of teachers and requirement of peer reviewed publication for submission of Ph.D thesis etc. The list of journals included in the various databases and abstracting journals etc submitted by the Departments recommended for further processing as per UGC guidelines. It is also resolved that for the purpose of Impact Factor calculation, only the Impact Factor published by Thomson-Reuter is to be considered as the authentic.
