G.S.R 89.—In view of the orders dated 12-10-2009 and 4-11-2009 passed by Hon'ble Rajasthan High Court, Jaipur Bench in D.B. Civil Writ Petition (PIL) No. 12810/2009- G.Sharma V/s State of Rajasthan, restricting the vertical reservation to 50%, a difficulty has arisen in the implementation of the Rajasthan Scheduled Castes, Scheduled Tribes, Backward Classes, Special Backward Classes and Economically Backward Classes (Reservation of Seats in Educational Institutions in the State and of appointments and posts in services under the State) Act, 2008, the State Government hereby provisionally modifies the reservation in recruitment and admissions in the following manner:-

Scheduled Castes	16%
Scheduled Tribes	12%
Backward Classes	21% (including the persons belonging to Special Backward Classes)

This order shall remain in force till the Hon'ble court passes any further order or decision in the above-mentioned writ petition in this regard.

further to amend the Rajasthan Backward Classes (Reservation of Seats in Educational Institutions in the State and of Appointments and Posts in Services under the State) Act, 2017.

Be it enacted by the Rajasthan State Legislature in the Seventieth Year of the Republic of India, as follows:-

1. Short title and commencement.- (1) This Act may be called the Rajasthan Backward Classes (Reservation of Seats in Educational Institutions in the State and of Appointments and Posts in Services under the State) (Amendment) Act, 2019.

(2) It shall come into force at once.

2. Amendment of section 3, Rajasthan Act No. 38 of 2017.- For the existing sub-section (1) of section 3 of the Rajasthan Backward Classes (Reservation of Seats in Educational Institutions in the State and of Appointments and Posts in Services under the State) Act, 2017 (Act No. 38 of 2017), hereinafter in this Act referred to as the principal Act, the following shall be substituted, namely:-

“(1) The reservation in respect of the annual permitted strength for admission into such educational institutions and courses in the State, as may be prescribed, for the More Backward Classes shall be five percent.”.

3. Amendment of section 4, Rajasthan Act No. 38 of 2017.- For the existing sub-section (1) of section 4 of the principal Act, the following shall be substituted, namely :-

“(1) The reservation of appointments and posts in the services under the State for the More Backward Classes shall be five percent.”.

माननीय राजस्थान उच्च न्यायालय पीठ जयपुर द्वारा डी.बी. सिविल रिट याचिका संख्या 12810 / 2009 जी. शर्मा बनाम राजस्थान राज्य में पारित निर्णय दिनांक 22.12.2010 की पालना में राजस्थान राज्य पिछड़ा वर्ग आयोग की विशेष पिछड़ा वर्ग आरक्षण से संबंधित रिपोर्ट नवम्बर, 2012 पर विचार कर राज्य सरकार द्वारा निर्णय लिया गया है कि वर्तमान में उपलब्ध 49 प्रतिशत आरक्षण के अतिरिक्त आयोग की अनुशंसा के आधार पर विशेष पिछड़ी 5 जातियों (I) बंजरा, बालदिया, लबाना (II) गाडिया लोहार व गाडोलिया (III) गूजर, गुर्जर (IV) राईका, रेबारी (देबासी) एवं (V) गडरिया (गाडरी), गायरी को राज्य की शौक्षिक संस्थाओं में सीटों और राज्य के अधीन सेवाओं में नियुक्तियों और पदों में सीधी भर्ती के लिए 5 प्रतिशत आरक्षण Act of 2008 के अनुसार दिया जावे। राज्य सरकार का उक्त निर्णय, उच्च न्यायालय के दिनांक 22.12.2010 के निवेशानुसार, इस आदेश के राजपत्र में प्रकाशन की तिथि से 2 माह पश्चात् से प्रभावी होगा। उक्त 2 माह की अवधि में इस विभाग के समसंख्यक आदेश दिनांक 06.05.2010 यथा संशोधित आदेश दिनांक 07.08.2012 के द्वारा विशेष पिछड़ा वर्ग के लिए प्रदत्त 1 प्रतिशत आरक्षण की व्यवस्था जारी रहेगी। इसी प्रकार इस विभाग के समसंख्यक आदेश दिनांक 31.01.2011 के द्वारा भर्ती के लिए विज्ञापित पदों के 4 प्रतिशत अतिरिक्त पद विशेष पिछड़ा वर्ग के लिये निर्धारित रखे जा कर सुरक्षित रखे जाने संबंधी व्यवस्था भी इस आदेश के प्रभावी होने तक प्रभावी रहेगी।

राजस्थान राज्य में राज्य के अधीन सेवाओं में एवं शैक्षणिक संस्थाओं में संचालित पाठ्यक्रमों में, राज्य द्वारा समय-समय पर प्रसारित आदेशों के तहत विभिन्न वर्गों को आरक्षण प्रदान किया जा रहा है। इन वर्गों में अनुसूचित जाति, अनुसूचित जनजाति, पिछड़ा वर्ग, विशेष पिछड़ा वर्ग आदि शामिल हैं।

हाल में, दिनांक 16.10.15 को जारी अधिसूचना द्वारा विशेष पिछड़ा वर्ग आरक्षण संबंधी अधिनियम, 2015 को लागू किया जा चुका है, जिसके द्वारा पूर्व में आदेश दिनांक 06.05.10 एवं पश्चात्वर्ती आदेशों द्वारा लागू 1 प्रतिशत विशेष पिछड़ा वर्ग (SBC) आरक्षण, को बढ़ाकर 5 प्रतिशत किया जा चुका है। अन्य वर्गों के आरक्षण में कोई परिवर्तन नहीं किया गया है।

अतः एतद्वारा समर्त संबंधित प्रशासनिक विभागों को व्यादिष्ट किया जाता है कि वे अपने अधीनस्थ शैक्षणिक संस्थाओं में संचालित पाठ्यक्रमों में अन्य वर्गों के आरक्षण को यथावत् रखते हुए, सत्र वर्ष 2016-17 से विशेष पिछड़ा वर्ग को 1 प्रतिशत के स्थान पर 5 प्रतिशत आरक्षण दिया जाना सुनिश्चित करें।



इसके अलावा सीधी भर्ती में अन्य प्रवर्गों के लिए किया गया आरक्षण जैसे निःशक्तजन के लिए 3 प्रतिशत राजस्थान सिविल सर्विसेज (एब्झॉब्शन आफ एक्स सर्विसेज) रूल्स, 1988 के अन्तर्गत भूतपूर्व सैनिकों के लिए अधीनस्थ सेवाओं और मन्त्रालयिक सेवाओं में 12½ प्रतिशत तथा चतुर्थ श्रेणी सेवा में 15 प्रतिशत आरक्षण है इसी प्रकार सभी सेवाओं में महिला अध्यर्थियों के लिए 30 प्रतिशत, उत्कृष्ट खिलाड़ियों के लिए अधीनस्थ सेवाओं और मन्त्रालयिक सेवाओं में 2 प्रतिशत का आरक्षण का प्रावधान है और ये सभी आरक्षण दण्डवत माना गया है । क्योंकि इन्द्र साहनी के सामले में (ए.आई.आर. 1993 एस.सी.477) में उच्चतम न्यायालय के निर्णय के अनुसार भारत के संविधान के अनुच्छेद 16 के खण्ड 4 में अनुज्ञात आरक्षण 50 प्रतिशत से अधिक नहीं होना चाहिए ।

राजस्थान निःशक्त व्यक्तियों का नियोजन नियम, 2000 में अधिसूचना दिनांक 10.10.2002 द्वारा रिक्तियों का 3 प्रतिशत आरक्षण निःशक्तजन हेतु सभी पदों पर कर दिया गया है जिन पर निःशक्त व्यक्ति (समान अवसर, अधिकार, संरक्षण एवं पूर्ण भागीदारी) अधिनियम, 1995 की धारा 32 के अधीन भारत सरकार द्वारा प्रत्येक निःशक्तता के लिए निःशक्त व्यक्तियों हेतु आरक्षित किया गया है । इसी कम में कठिपय विभागों में ग्रान्तियाँ/शंकाएँ अभिव्यक्त की हैं कि आज्ञा दिनांक 09.7.85 के अनुसार निःशक्तजन हेतु जो रोस्टर बिन्दु निर्धारित किए गए हैं, वे स्वतः समाप्त हो गये हैं । अतः इस स्थिति को स्पष्ट करने हेतु कार्मिक विभाग की आज्ञा दिनांक 09.7.85 के अतिकरण में एवं इस विभाग का समसंख्यक परिपत्रादेश दिनांक 20.11.97 के कम में सीधी भर्ती के लिए विद्यमान 100 बिन्दु रोस्टर अर्थात् उपाबन्ध-II में उपदर्शित मॉडल के अनुसार संशोधित किया गया है ।

जहाँ तक पदोन्नति का संबंध है, विद्यमान आरक्षण रोस्टर में कोई परिवर्तन नहीं है ।

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Various Service Rules as mentioned in the Schedule appended hereto, namely:-

- 1. Short title and commencement.**- (1) These rules may be called the Rajasthan Various Service (Amendment) Rules, 2019.
(2) They shall come into force with immediate effect.

2. Amendment.- (1) After the existing rule mentioned in column number 3 against each of the service rules as mentioned in column number 2 of the Schedule given below, the following new rule as mentioned in column number 4 shall be added, namely:-

" Reservation of vacancies for Economically Weaker Sections:- Reservation of vacancies for Economically Weaker Sections shall be 10% in direct recruitment in addition to the existing reservation. In the event of non- availability of eligible and suitable candidate amongst Economically Weaker Sections in a particular year, the vacancies so reserved for them shall be filled in accordance with the normal procedure.

Explanation: For the purpose of this rule 'Economically Weaker Sections' shall be the persons who are bonafide resident of Rajasthan and not covered under the existing scheme of reservations for the Scheduled Castes, the Scheduled Tribes, the Backward Classes, the More Backward Classes and whose family has gross annual income below rupees 8.00 lakh. Family for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years. The income shall include income from all sources i.e. salary, agriculture, business, profession etc. and it will be income for the financial year prior to the year of application. Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as, 'Economically Weaker Sections', irrespective of the family income:-

- (i) 5 acres of Agricultural Land and above;
- (ii) Residential flat of 1000 sq. ft. and above;
- (iii) Residential plot of 100 sq. yards and above in notified municipalities; or
- (iv) Residential plot of 200 sq. yards and above in areas other than the notified municipalities."





(2) They shall come into force with immediate effect.

2. Addition of new Rule 8A.- After the existing rule 8 of the Rajasthan Public Service Commission (Ministerial and Subordinate Service) Rules and Regulations, 1999, hereinafter referred to as the said rules and regulations, the following new rule shall be added, namely:-"

"8A. Reservation of vacancies for Economically Weaker Sections.- Reservation of vacancies for Economically Weaker Sections shall be 10% in direct recruitment in addition to the existing reservation. In the event of non-availability of eligible and suitable candidate amongst Economically Weaker Sections in a particular year, the vacancies so reserved for them shall be filled in accordance with the normal procedure.

Explanation: For the purpose of this rule '**Economically Weaker Sections**' shall be the persons who are bonafide resident of Rajasthan and not covered under the existing scheme of reservations for the Scheduled Castes, the Scheduled Tribes, the Backward Classes, the More Backward Classes and whose family has gross annual income below rupees 8.00 lakh. Family for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years. The income shall include income from all sources i.e. salary, agriculture, business, profession etc. and it will be income for the financial year prior to the year of application. Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as, '**Economically Weaker Sections**', irrespective of the family income:-

- (i) 5 acres of Agricultural Land and above;
- (ii) Residential flat of 1000 sq. ft. and above;
- (iii) Residential plot of 100 sq. yards and above in notified municipalities; or
- (iv) Residential plot of 200 sq. yards and above in areas other than the notified municipalities."



OFFICE MEMORANDUM

Subject: Reservation for Economically Weaker Sections (EWSs) in direct recruitment in civil posts and services in the Government of India.

- In continuation of this Department's Office Memorandum of even number dated 19.01.2019, the following instructions are issued in consultation with Ministry of Social Justice and Empowerment and Department of Legal Affairs regarding reservation for EWSs not covered under the reservation scheme for SCs/STs/OBCs in respect of direct recruitment in civil posts and services in the Government of India.

2. QUANTUM OF RESERVATION

The persons belonging to EWSs who are not covered under the scheme of reservation for SCs, STs and OBCs shall get 10% reservation in direct recruitment in civil posts and services in the Government of India.

3. EXEMPTION FROM RESERVATION:

3.1 "Scientific and Technical" posts which satisfy all the following conditions can be exempted from the purview of the reservation orders by the Ministries/ Departments:

- (i) The posts should be in grades above the lowest grade in Group A of the service concerned.
- (ii) They should be classified as "scientific or technical" in terms of Cabinet Secretariat [OM No. 85/11/CF-61(1) dated 28.12.1961], according to which scientific and technical posts for which qualifications in the natural sciences or exact sciences or applied sciences or in technology are prescribed and the incumbents of which have to use that knowledge in the discharge of their duties.

[iii] The posts should be 'for conducting research' or 'for organizing, guiding and directing research'.

3.2 Orders of the Minister concerned should be obtained before exempting any posts satisfying the above condition from the purview of the scheme of reservation.

4. CRITERIA OF INCOME & ASSETS:

4.1 Persons who are not covered under the scheme of reservation for SCs, STs and OBCs and whose family has gross annual income below Rs. 8.00 lakh (Rupees eight lakh only) are to be identified as EWSs for benefit of reservation. Income shall also include income from all sources i.e. salary, agriculture, business, profession, etc. for the financial year prior to the year of application.

Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income:-

- i. 5 acres of agricultural land and above;
- ii. Residential flat of 1000 sq. ft. and above;
- iii. Residential plot of 100 sq. yards and above in notified municipalities;
- iv. Residential plot of 200 sq. yards and above in areas other than the notified municipalities.

4.2 The property held by a "Family" in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status.

4.3 The term "Family" for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years.

5. INCOME AND ASSET CERTIFICATE ISSUING AUTHORITY AND VERIFICATION OF CERTIFICATE:

5.1 The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority. The Income and Asset Certificate issued by any one of the following authorities in the prescribed format as given in Annexure-I shall only be accepted as proof of candidate's claim as belonging to EWS:-

- (i) District Magistrate/Additional District Magistrate/ Collector/ Deputy Commissioner/Additional Deputy Commissioner/1st Class Stipendiary

- Magistrate/ Sub Divisional Magistrate/ Taluka Magistrate/ Executive Magistrate/ Extra Assistant Commissioner
- (ii) Chief Presidency Magistrate/Additional Chief Presidency Magistrate/ Presidency Magistrate
 - (iii) Revenue Officer not below the rank of Tehsildar and
 - (iv) Sub-Divisional Officer or the area where the candidate and/or his family normally resides.

5.2 The Officer who issues the certificate would do the same after carefully verifying all relevant documents following due process as prescribed by the respective State/UT.

5.3 The crucial date for submitting income and asset certificate by the candidate may be treated as the closing date for receipt of application for the post, except in cases where crucial date is fixed otherwise.

5.4 The appointing authorities should, in the offer of appointment to the candidates claiming to be belonging to EWS, include the following clause :-

"The appointment is provisional and is subject to the Income and asset certificate being verified through the proper channels and if the verification reveals that the claim to belong to EWS is fake/false the services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of fake/false certificate."

The appointing authority should verify the veracity of the Income and asset certificate submitted by the candidate through the certificate issuing authority.

5.5 Instructions referred to above should be strictly followed so that it may not be possible for an unscrupulous person to secure employment on the basis of a false claim and if any person gets an appointment on the basis of such false claim, her/his services shall be terminated invoking the conditions contained in the offer of appointment.

6. EFFECTING RESERVATION - MAINTENANCE OF ROSTERS:

6.1 Department of Personnel and Training had circulated Office Memorandum No.36012/2/96-Estt(Res) dated July 2, 1997 regarding implementation of post based reservation roster. The general principles for making and operating post

based reservation roster would be as per the principles laid down in the said Office Memorandum.

6.2 Every Government establishment shall now recast group-wise post-based reservation roster register for direct recruitment in accordance with format given in Annexure II, III, IV and V, as the case may be, for effecting 10% reservation for EWSs interpolating them with the SCs, STs and OBCs. While fixing roster point, if the EWS roster point coincides with the roster points of SCs/STs/OBCs the next available UR roster point has been allotted to the EWSs and also the principle of "squeezing" has been kept in view. While drawing up the rosters, the cadre controlling authorities may similarly "squeeze" the last points of the roster so as to meet prescribed 10% reservation.

6.3 Where in any recruitment year any vacancy earmarked for EWS cannot be filled up due to non availability of a suitable candidate belonging to EWS, such vacancies for that particular recruitment year shall not be carried forward to the next recruitment year as backlog.

6.4 Persons belonging to EWS selected against the quota for persons with benchmark disabilities/ex-servicemen shall be placed against the roster points earmarked for EWS.

7. ADJUSTMENT AGAINST UNRESERVED VACANCIES:

A person belonging to EWS cannot be denied the right to compete for appointment against an unreserved vacancy. Persons belonging to EWS who are selected on the basis of merit and not on account of reservation are not to be counted towards the quota meant for reservation.

8. FORTNIGHTLY/ANNUAL REPORTS REGARDING REPRESENTATION OF EWS:

The Ministries/Departments shall send single consolidated fortnightly report including their attached/subordinate offices beginning from 15.2.2019 as per format at Annexure-VI.

From 01.01.2020, the Ministries/Departments shall upload data on representation of EWSs in respect of posts/services under the Central Government on the URL i.e. www.rrcps.nic.in as on 1st January of every year. All Ministries/Departments have already been provided respective usercode and password with guidelines for operating the URL.

9. MAINTENANCE OF REGISTER OF COMPLAINTS BY THE GOVERNMENT ESTABLISHMENT:

9.1 Every Government establishment shall appoint a senior officer of the Department as the Grievance Redressal Officer.

9.2 Any person aggrieved with any matter relating to discrimination in employment against any EWS may file a complaint with the Grievance Redressal Officer of the respective Government establishment. The name, designation and contact details of the Grievance Redressal Officer may be displayed prominently on the website and in the office of the concerned establishment.

10. LIAISON OFFICER:

Ministries/Departments/Attached and Subordinate Offices shall appoint Liaison Officer to monitor the implementation of reservation for EWSs.

11. The above scheme of reservation will be effective in respect of all direct recruitment vacancies to be notified on or after 01.02.2019.

12. All the Ministries/Departments are requested to bring the above instructions to the notice of all appointing authorities under their control. In case of any difficulty with regard to implementation of the provisions of this OM, the concerned authorities may consult DOP&T through their administrative Ministry/Department.

In accordance with the provisions of the Constitution (One Hundred and Third Amendment) Act 2019, and the reference of Ministry of Social Justice and Empowerment vide OM No. 20013/01/2018-BC-II dated 17th January 2019, enabling provision of reservation for the Economically Weaker Sections (EWSs) who are not covered under the existing scheme of reservations for the Scheduled Castes, the Scheduled Tribes and the Socially and Educationally Backward Classes. It has been decided to provide reservation in admission to educational institutions subject to a maximum of ten per cent of the total seats in each category. This would not apply to the minority educational institutions referred to in clause (1) of Article 30 of the Constitution of India.

2. The provision of reservations to the Economically Weaker Sections shall be in accordance with the directions contained in the OM No. 20013/01/2018-BC-II dated 17th January 2019 of the Ministry of Social Justice & Empowerment and shall be subject to the following:


- The reservations shall be provided to EWSs for admission in Central Educational Institutions, (as defined in clause (d) of section (2) of The Central Educational Institutions (Reservation in Admission) Act, 2006) from the academic year 2019-20 onwards.
- The above reservation would not be applicable to the 8 institutions of excellence, research institutions, institutions of national & strategic importance as specified in the Schedule to The Central Educational Institutions (Reservation in Admission) Act, 2006, as amended from time to time, and appended to this OM, and to the minority educational institutions referred to in clause (1) of article 30 of the Constitution.
- Every Central Educational Institution shall, with the prior approval of the appropriate authority (as defined in clause (c) of section 2 of The Central Educational Institutions (Reservation in Admission) Act, 2006), increase the number of seats over and above its annual permitted strength in each branch of

- study or faculty so that the number of seats available, excluding those reserved for the persons belonging to the EWSs, is not less than the number of such seats available, in each category, for the academic session immediately preceding the date of the coming into force of this O.M.
- d) Where, on a representation by any Central Educational Institution, the appropriate authority is satisfied that for reasons of financial, physical or academic limitations or in order to maintain the standards of education, the annual permitted strength in any branch of study or faculty of such institution cannot be increased for the academic session following the commencement of this Act, it may permit such institution to increase the annual permitted strength over a maximum period of two years beginning with the academic session following the commencement of this Act; and then, the extent of reservation for the Economically Weaker Sections shall be limited for that academic session in such manner that the number of seats made available to the Economically Weaker Sections for each academic session shall not reduce the number and the percentage of reservations provided for SC/ST/OBC categories.
- e) The scheme for implementing the reservation for the EWS shall be displayed on the website of the institution as soon as possible, but no later than 31st March 2019.

3. The Chairman UGC, Chairman AICTE and Chairperson NCTE and the Bureau Heads of the Department of Higher Education in the Ministry of Human Resource Development responsible for management of the Institutions of National Importance are requested to ensure immediate compliance of this OM.





NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Various Service Rules as mentioned in the Schedule appended hereto, namely:-

1. Short title and commencement.- (1) These rules may be called the Rajasthan Various Service (Amendment) Rules, 2019.
(2) They shall come into force with immediate effect.

2. Amendment.- (1) After the existing rule mentioned in column number 3 against each of the service rules as mentioned in column number 2 of the Schedule given below, the following new rule as mentioned in column number 4 shall be added, namely:

"Reservation of vacancies for Economically Weaker Sections:- Reservation of vacancies for Economically Weaker Sections shall be 10% in direct recruitment in addition to the existing reservation. In the event of non-availability of eligible and suitable candidate amongst Economically Weaker Sections in a particular year, the vacancies so reserved for them shall be filled in accordance with the normal procedure."

Explanation: For the purpose of this rule 'Economically Weaker Sections' shall be the persons who are bonafide resident of Rajasthan and not covered under the existing scheme of reservations for the Scheduled Castes, the Scheduled Tribes, the Backward Classes, the More Backward Classes and whose family has gross annual income below rupees 8.00 lakh. Family for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years. The income shall include income from all sources i.e. salary, agriculture, business, profession etc. and it will be income for the financial year prior to the year of application. Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as 'Economically Weaker Sections', irrespective of the family income:-

- (i) 5 acres of Agricultural Land and above;
- (ii) Residential flat of 1000 sq. ft. and above;
- (iii) Residential plot of 100 sq. yards and above in notified municipalities; or
- (iv) Residential plot of 200 sq. yards and above in areas other than the notified municipalities."

(2) In the existing rule as mentioned in the column number 5 against each of the service rules as mentioned in the column number 2 of the Schedule given below, for the existing expression "woman candidates belonging to general category and Economically backward classes", the expression "woman candidates belonging to General Category, Economically Backward Classes and Economically Weaker Sections" shall be substituted.
