In the year 2016-17 a through restructuring and revision of syllabus of MA Economics Programme had been done to make the syllabus compatible with the CBCS system. The new syllabus of MA Economics CBCS was introduced in 2017-18 for the first and second semester and in 2018-19 for third and fourth semester. The course entitled "PROJECT WORK- DISSERTATION" was also introduced in 2018-19 as core paper in MA IV Semester syllabus. This course was introduced with the aim to expose students with ground level reality and to provide them the opportunity to conduct field surveys. But it requires research aptitude and some resources. The students from poor background cannot afford the expenses of field survey. Many students found it expensive and are of the opinion that the Department must offer an optional paper for this as mentioned in their feedbacks. Even many Faculty members of the department are of the same opinion. So a meeting of committee was held on 14th Aug. 2019 to revise the syllabus of MA) Economics IV semester (CBCS). The Committee resolved to introduce a new paper "Public Policy in India" in option with Dissertation and approved its syllabus.

The minutes of the Committee of Courses were unanimously approved in the meeting of Faculty of Social Sciences held on 17.08.2019 and further approved under section 12(6) by Vice-Chancellor on 16.10.2019.
