At the outset, Member Secretary extended a hearty welcome to all the members present in the meeting. Following agendas were taken up:


1.	<p>To consider the letter received from Udaipur Development Authority letter dated 29.10.2025 regarding land acquisition of Kamla Nehru Hostel, Mohanlal Sukhadia University, Udaipur.</p> <p>Resolution: The Registrar apprised the House that the Udaipur Development Authority (UDA) had acquired land belonging to the University's Kamla Nehru Hostel and had deposited the due compensation amount of ₹ 60,24,448/- into the University's account, in accordance with the prescribed rules.</p> <p>In this connection, a meeting was held at the Vice-Chancellor's Secretariat, Mohanlal Sukhadia University, Udaipur, attended by the Vice-Chancellor, the City MLA Shri Tarachand Jain, the Commissioner, UDA, Shri Rahul Jain, IAS, the Registrar, the Comptroller and other concerned officials.</p> <p>During the course of meeting, the City MLA Shri Tarachand Jain and the Commissioner, UDA, Shri Rahul Jain expressed their expectation of cooperation from the University and assured that necessary assistance would be extended for other developmental works of the University through UDA and MLA funds.</p>

	After due deliberation, the Board of Management accorded in-principle approval to the matter in the interest of public interest, subject to the final approval of the State Government.
2.	<p>To report and discuss the notices issued to Dr. Mahendra Singh Dhaka, Professor of Physics and reply received.</p> <p>Resolution: The matter was discussed in light of the directions issued by the Hon'ble Governor and Chancellor of Mohanlal Sukhadia University, Udaipur, and on the recommendations of the Enquiry Committee, the University decided to proceed on the basis of the said report.</p> <p>In pursuance thereof, the University issued vide Notices No. 1715 dated 28.11.2025, No. 1723 dated 08.12.2025 and No. 1730 dated 15.12.2025 to Dr. Mahendra Singh Dhaka. Dr. Mahendra Singh Dhaka failed to submit any supporting documents in response to the allegations contained in the Enquiry Committee's report.</p> <p>After due consideration of the Enquiry Committee's report along with the documents annexed thereto, it was resolved that the services of Dr. Mahendra Singh Dhaka, Department of Physics, University College of Science, Mohanlal Sukhadia University, Udaipur, be removed from the University under the provisions of the University Act and Statutes No. 50 (Teachers' Service Conditions), Part VII (Penalties, Appeals and Review), Statute 73 (vi), with immediate effect.</p>
3.	<p>To re-consider the letter received from the Secretary, Governor's Secretariat, Jaipur vide letter No. 5347 dated 03.10.2025 along-with Enquiry Committee report as constituted by the Lok Bhawan vide letter No. F.3(1)RB/2021/part-3/3789 dated 14.07.2023 regarding enquire the matter of decision taken in BoM meeting held on 01.07.2023 under the Chairmanship of Prof. Bhagirath Singh regarding BoM.</p> <p>Resolution: Considered the matter and resolved that Letter No. 1737 dated 23.12.2025 has been issued to the Secretary, Governor's Secretariat, Jaipur, seeking the report along with relevant enclosures. Upon receipt of the said report and accompanying documents, appropriate action will be taken in accordance with the directions of Lok Bhawan.</p>
4.	<p>To report various orders/notifications/letters issued by the Univesity (from Sr. No. 1 to 5).</p> <p>Resolution: Considered and resolved to approve the same.</p>

T-1.	<p>To consider the letter dated 10.11.2025 received from the President, NTSA regarding the provision of medical facilities to all Rajasthan Government employees in accordance with the State Government circular dated 19.04.2022.</p> <p>Resolution: The House considered the said letter regarding provision of medical facilities to all Rajasthan Government employees in accordance with the State Government circular dated 19.04.2022. The House was apprised that, at present, a deduction of ₹875 per month is being made from all employees towards RGHS, which is causing financial hardship to University employees. Therefore, it was principally resolved that the deduction towards RGHS shall be made strictly in accordance with the State Government Circular dated 19.04.2022, and the balance amount, if any, shall be adjusted from the Self Financing Fund.</p>

T-2.	<p>To report and discuss the notices issued to Dr. Mahendra Singh Dhaka, Professor of Physics and reply received.</p> <p>Resolution: Already resolved at pt. no. 2.</p>

O-1.	<p>To open the envelope to make promotion under UGC- Career Advancement Schemes of Assistant Professor of Library & Information Sciences and Assistant Librarian.</p> <p>Resolution: Considered and resolved to open the envelope of Library Science containing the recommendations of the Screening-cum-Evaluation Committee constituted for granting promotion under the UGC Career Advancement Scheme from Level 10 to Level 11 in respect of Assistant Librarians and provide the same to the office of the Registrar for issuance of the orders.</p> <p>Further, another envelope pertaining to Dr. Prabhat Singh Rajput, Assistant Professor of Library & Information Science containing the recommendations of the Screening-cum-Evaluation Committee was also opened.</p> <p>After detailed discussion, it was resolved that the services rendered by Dr. P.S. Rajput as an Assistant Librarian cannot be considered at par with Academic Services; therefore, counting of past services in the said capacity is not permissible, as per the report of the Comptroller.</p> <p>Further, it was resolved that Dr. P.S. Rajput can grant CAS promotion in accordance with his appointment on the post of Assistant Professor, Department of Library & Information Science.</p>
O-2.	<p>Considered the request of Dr. Gatu Lal Patidar, Assistant Professor of Sanskrit seeking notional increment for the period he remained on lien to serve as an Associate Professor at the University of Himachal Pradesh.</p> <p>Resolution: Considered the request received from Dr. Gatu Lal Patidar and resolved that a detailed Factual Report of the matter be prepared and sent to the State Government for further directions.</p>
