 - Considered confirmation of minutes of last COD meeting held on 14.5.2007.

Resolved to confirm minutes of COD Meeting held on 14.5.2007.

Considered an application of students duly forwarded by the Dean, University College of Co0mmerce & Management Studies, Udaipur dated 13.7.2007 requesting to conduct an examination for their I Year due papers in which they remain failed in 2007 examination, but passed in all papers of II Year TDC examination in 2007.

After discussion Resolved as under: -

- (i) That no special examination can be conducted immediately for the students for passing out their I Year due paper. As per existing provision such candidates are to appear only in 2008 annual examination to clear their I Year due paper.
- (ii) However, such candidates who have already passed in all the II Year TDC papers but remain failed in their I Year due paper, may be provided an opportunity to apply for immediate special re-evaluation as per rules with the prescribed fee of Rs. 1200/- per paper so that they can get admission in final year TDC Class during 2007-08 in time, in case they pass out their I Year due papers.
- Considered a letter No.RB/2007/35592 dated 2.7.2007 received from Raj Bhawan,
 Jaipur regarding appointment of Programme Coordinator for NSS.

Resolved that after the completion of term of present NSS Coordinator, next appointment on this post be made as per the procedure laid down by the Govt. of India as circulated by Raj Bhawan through the letter under reference.

4. Considered a letter No.10004 dated 9.7.2007 duly forwarded by the Dean, College of Law stating that as per University rule printed in the information Bulletin – admission fee do not refunded, whereas as per UGC circular such fee should be refunded.

Resolved that the UGC rules regarding refund of admission fee be also adopted in the University from the academic session 2007-08 and cases of refund of fee, if any may be decided as per UGC rules.

 Considered a letter No.860 dated 19.4.2007 received from the Head, Department of Accountancy & Statistics duly forwarded by the Dean, University College of commerce & Management Studies regarding updation of the paper 3930:Indirect Taxes- III Year TDC Commerce w.e.f. 2007-08. At the time of consideration of above letter the Dean and Chairman, Faculty of Commerce inform that the above matter pertaining to syllabus of B.Com. has already taken up in their Faculty meeting for consideration of the Academic Council. Therefore, the item was DROPPED.
