

CP-102 : QUANTITATIVE METHODS**Objectives**

The objective of the course is to make the students familiar with some basic statistical and linear programming techniques. The main focus, however, is in their applications in business decision making.

Course Contents

Mathematical basis of managerial decision : Functions-Applications of Functions-Some special Functions. A.P. & G.P. and their managerial application, Matrices, Markov Chains & their applications; Frequency Distribution and their Analysis; Measures of central, tendency, standard deviation, Variance Correlation and Regression Analysis; Time Series Analysis and Forecasting ; Probability Theory and Probability Distribution - Binomial Poisson, Normal and Exponential, Multivariate Analysis.
